The Station will conduct the **KBUL "VIP NAME GAME**" Contest (the õContestö) substantially as described in these rules, and by participating, each participant agrees as follows:

Eligibility. Any attempt by any participant to submit more than one (1) entry by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disgualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The õauthorized account holderö is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

If the qualifier doesn¢t call within the such allotted announced at or around 3:10pm PT (Fridays) and at or around

8:10am PT (Mondays). This process will continue if no winner is determined one more time on Fridays at or around 4:10pm PT and Mondays at or around 9:10am PT. If no winner is determined at that time, then there will be no winner on those particular days. If a qualifier calls within allotted time, such qualifier will be the winner of a Grand Prize (as defined below) for that day. The selection of the potential winner are final and binding in all matters related to the Contest.

- 5. Verification of Potential Winner.
